



**Club Grants Funding/Sponsorship Agreement between:**

Blacktown RSL Club Ltd ( the Club ) agrees to provide a cash grant of \$ inclusive of gst to your organisation or association as per funding request for the sole purposes as defined within your written application dated .

The organisation shall not use or divert the funding to any other purposes whatsoever without the prior express written approval of the Club. The funds are only provided for the purpose or purposes as defined within your original submission for funds.

In return your organisation is asked to support the Club as follows:

1. The Club to be clearly advertised as follows for a minimum period of 1 year from the date of funding:
  - a) via prominent branding on the product or products being purchased with the grant
  - b) via your website, including links to the Club website
  - c) via any and all news journals, information notices etc as provided by your club or association
  - d) via prominent branding of an equal size to other sponsors on the exterior of your building, jumpers, jerseys, training shirts, etc as applicable and the same number of signs as other sponsors.
  - e) Any other form of advertising you do whether electronic, media or otherwise
  - f) any other form of advertising as agreed
  - g) any combination of the above as agreed
2. The costs associated with item 1 above shall be borne by your organisation

3. Your organisation or association is asked to hold the following at the Club premises:
  - a) Fund raising events
  - b) Presentation event
  - c) Any other function or event as conducted by you
  - d) meetings
  
4. The Club does not expect every event as per 3 to be held at the Club, however, an agreed frequency of said events is agreed as follows:
  - a) ..... times per year – fund raising
  - b) ..... times per year – presentations
  - c) ..... times per year – other functions
  - d) ..... times per year – meetings
  
5. Your association agrees for the Club to use any and all photographs, video etc of the funding process and items as sponsored, including cheque handover in any way the Club deems appropriate.
  
6. Your association is to actively encourage your members or the parents of your members as applicable to join the RSL as members and to actively support the good name of the Club and support the Club by attending it on a social basis regularly.
  
7. You agree that any loss, damage, injury no matter howsoever caused by any goods or services you acquire from the funds as provided by the Club becomes the sole responsibility of your association and the Club is in no way liable for any acts or omissions of your association, employees or servants, whether paid or otherwise.
  
8. You agree to repay any funding in full if your Association uses the funds for any other purpose that was not approved by the Club. You further agree to repay the funding in the event of your association or club closing, winding up, ceases business or operations, or becomes insolvent during this Club Grants funding period.
  
9. You agree to provide the Club a receipt for the funded amount and evidence of the use of the funds – by way of copies of receipts and an acquittal report

10. You declare you are not receiving funding from another Registered Club, Organisation or any form of government grant or fund raising for the purpose of your application.

11. You declare you are not financially supporting any other Licensed Club or hotel by holding paid for events, functions, meetings or presentations at those premises in preference to Blacktown RSL.

Failure to abide by the agreed conditions and declarations above will result in future funding requests being declined.

The Club is pleased to support the community and is especially proud to be able to support your highly important and valued community association. The Club looks forward to maintaining the relationship for years to come.
